INTERCLUB PENNANTS & HALF DAY 6'S BOWLS 3FIVE 1-5 YEAR

We are one of the few bowling clubs with big number of members, and should be well represented in these events. Members, especially the ladies, are encouraged to take part representing the club. Please put up your names now so that the Selection Committee can better put you all into teams and send in the entries to Bowls Auckland before the closing dates.

MOBILITY PARKING

There is a Mobility Parking lot recently set up at the front of the main building. Please do not park your vehicle there if you do not hold a Mobility Parking Permit. You are also not allowed to park in the first empty lot next to Green B as it is reserved for Emergency Vehicle. Lastly, please do not park in any of the designated lots allocated to the Office Bearers and other members with the relevant responsibilities. Thank you.

LAWS OF THE SPORTS OF BOWLS

These are the questions from the last Newsletter and now the answers:

- (a) Under what conditions are you allowed to change your set of bowls during a game?
- If a bowl is damaged after being struck by another bowl;
- If a bowl at rest splits into pieces without being struck by any bowl;
- If the game has been moved between a vegetation surface and a synthetic/indoor surface on the same day;
- If a game has been stopped and is continued on another day.
- (b) When is a bowl which touches the jack not considered as a toucher?
- If that bowl is neither marked nor nominated before the next delivered bowl comes to rest, it is not a toucher;
- A bowl which touches the jack in the ditch is not a toucher;
- A rebounding bowl from the face of the bank which touches the jack is not a toucher;
- A bowl which comes to rest/touching the outside edge of a line jack is also not a toucher.
- (c) When is a bowl which does not touch the jack but is marked as a toucher?
- If a bowl is a toucher and subsequently is damaged as (a) above, the replacement bowl must be marked as a toucher;
- If a player plays another player's bowl which touches the jack, the other player's bowl must be replaced by his/her own bowl and marked as a toucher.
- (d) In a quarter-final game of Fours being played over 18 ends. At the completion of 16th end the score is 29 to Team A and 10 to Team B. Do the players have to complete all 18 ends? What happens if the game is still in the qualifying rounds?
- There must not be further play as this is in a knock out stage where Team B could only score a maximum of 8 shots with 2 ends left and impossible to win the game. If the game is in qualifying rounds and Net Total of Shots is one of the conditions for qualifying, then they must continue to finish all the 18 ends.
- (e) Under what situations the Lead of the team who won the previous end does not deliver the first bowl of the next end?
- When an extra end is needed, the winner of the toss (if it is the winner of the previous end) can decide not to play first;
- Team A won the previous end and Lead A has the jack wrongly delivered. Lead B then redelivers the jack but it hits Skip B's foot. This scenario requires Lead A to deliver the jack the third time, but must not play first! The twist is in Laws 10.1, 10.2 and 38.1.1.1
